AOKI Seafood Co., Ltd. has gone bankrupt according to Decision No. 01/2025/QD-TBPS dated June 25, 2025 of the People's Court of Kien Giang province on the declaration of bankruptcy, the right to manage assets and handle finances belongs to the court and asset management officers. Therefore, Aoki Seafood Co., Ltd. is no longer a subsidiary of Kien Hung Joint Stock Company VN (KHS). Kien Hung Joint Stock Company VN will stop the procedures for making and disclosing information for the Consolidated Financial Statements from Q3 2025 and the fiscal year ending on December 31, 2025.
